Course Title: CIN 260H1S: Special Topics in Cinema Studies: Framing the Real: Reality Television and Documentary Cinema

Course description: This course will examine the contemporary format of reality television while engaging with its antecedents in documentary cinema. Questions explored will include the aesthetics of the real, celebrity and performance, and how both genres have served as platforms for queer and minoritarian voices.

Qualifications:

Required:

- MA in Cinema/Film.
- At least 3 years of experience teaching cinema and media at the university level, specifically film and media analysis
- At least 3 years of experience marking undergraduate essays in cinema.

Preferred:

- Scholarly concentration in film and popular culture beyond a Master's level.

Duties of Sessional Lecturer:

The Course Instructor will devise the syllabus for this particular course, conferring with the Director of CSI in the process. He or she will lecture/conduct classes, grade assignments, hold office hours each week, and answer questions by email or appointment.
